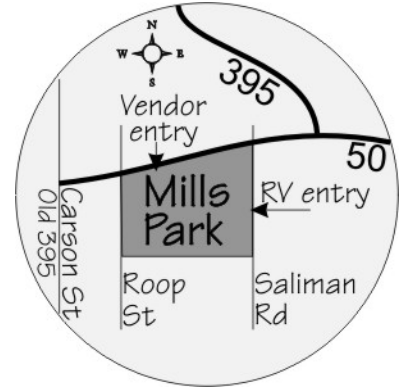
Vendor Hours: **Friday - NOON to 8 PM**                      **Saturday - 10 AM to 8 PM**                      **Sunday - 10 AM to 5 PM**

Location: Mills Park on Highway 50 East (William Street) between Roop Street and Saliman Road.

Setup Times: **Mountain Man Traders** will be assigned locations along Traders' Row by Kryer (775) 883-7736.

**Native American Traders** will be assigned locations in the Village by John Cline, after check in.

**All Other Vendors** must see Maxine for your assigned space. **No setup is allowed before checking in.** Setup begins **Thursday, 2 to 5 PM** and **Friday at 9 AM.**



Parking: **There is NO parking at your booth except during loading and unloading. The Parks Dept has stated that cars parked on the grass in the park WILL BE TOWED.** Also parking within 10 ft of the railroad tracks will get you **TOWED**. You may park your vehicle(s) at Carson High School, across Saliman Road from the east side of Mills Park, at the Carson City Library (Roop and Washington Streets) or street parking. There is parking along Highway 50 East. This parking is all free. If you requested RV parking, see Maxine for your parking pass and RV payment. *And finally, please leave the parking spaces closest to the event open for your customers.*

Food Vendors: You **must** contact the Carson City Health Department (775-887-2190) at least 5 days prior to the event and have met all requirements. The Health Department will want to see your permit at the Rendezvous, so bring it with you. We will sell ice for \$12 per 40 lb bag.

- All Vendors:
1. Booths must be properly manned during **ALL** event hours.
  2. Any remaining booth fee payment due for this event is payable **before** you set-up.
  3. We will be handing out Nevada State Sales Tax forms. You **MUST** return them at the end of the weekend - **THIS IS REQUIRED BY THE STATE OF NEVADA.** (If you already have a Nevada Sales Tax ID, just write it on the form and return it to me any time during the weekend.)
  4. **No dogs** are allowed in the park. Please leave your pets at home.

End of Event: There will be **NO** booth closures or autos/trailers on the grounds **before 5 PM on Sunday.** **Anyone who does not comply will not be able to return next year.**
